## **Prana Healing Holidays - Booking Conditions**

Please read below, sign and date at time of booking.

Your signature below will make the terms and conditions applicable to your booking.

► Price - A deposit of 50% of the full holiday price per person is due within 7 days of booking to secure the booking. The deposit is non refundable.

The balance of the price is due 30 days prior to departure, (*and may be paid in full or by instalments, after the deposit has been made, with full payment being received 30 days prior to departure.*) Payment will be made by direct deposit to Prana Healing Holidays (*details will be provided at time of booking*).

► Prior to arrival we require you to send a copy of your valid passport and Visa entry to India for us to forward on to the Pappukutty Beach Resort to follow travel safe protocol.

► Price variations - all pricing is current at time of printing, however currency fluctuations and prices cannot be guaranteed, and may change without notice, until the booking has been paid in full and documents have been issued.

► Cancellations - if the participant cancels more than 60 days prior to the departure date, the cancellation fee will be the amount of the deposit paid. If the cancellation is received less than 60 days but more than 30 days prior to the departure date, then the cancellation will be one half of the balance price payable (*not including deposit*). If the cancellation is less than 30 days prior to the departure date, then the cancellation fee will be equal to the price of the holiday.

► It is understood by agreeing to the Booking Conditions that you, the participant, understands that the holiday is provided as a complete package and is paid for, in advance, as such.

► Refunds will not be made for any activities, meals, accommodation or any other services included in the holiday package, which were not utilised, should you choose voluntarily to not use or participate in any activities during the experience.

► Any components of the package, as listed in the itinerary, that the participant does not wish to participate in may be negotiated prior to payment. It is also understood on payment that you agree to undertake the activities as presented in your itinerary.

► Group size - a minimum group size of 7 applies for a Group Healing Holiday. If less than 7 bookings are confirmed 60 days prior to the departure date, a choice will be provided to the participant not to proceed with the holiday, with a full refund of the price. Or to proceed with either a. go on a Personalised Holiday with minor adjustments to your itinerary to suit, or b. choose to continue the holiday, but with an extra supplement to cover the smaller group size.

# Prana Healing Holidays
